Dr. Fettrow,

With this memorandum, I am requesting the consent of the City Council to raise the existing **Private Extra-Duty Detail rate and corresponding Administrative Fee.** The Extra-Duty Detail rate **RPD/RFD** charges is reviewed annually, however has remained unchanged for years. With that said I am requesting the following changes to keep our rates in line with neighboring municipalities:

Current Hourly Rate  
\$30

Current Hourly Administrative Fee  
\$8

Proposed New Hourly Rate  
\$35

Proposed Hourly Administrative Fee  
\$10

The proposed rate changes will bring Rockledge Public Safety into the midrange of rates and fees however well below the high end of the range.
